

XI International Photo Contest  
*“Master’s Works as an inspiration of Contemporary Photography”*

The organizer: Dzielnicowy Dom Kultury „Bronowice” in Lublin  
The competition is open to young people aged 12 - 25

**Goals of the competition:**

- deepening knowledge and analysis of the chosen artist's work in an individualized and creative way;
- development of culture and visual sensitivity as well as creative activity of young people.

**Task realisation:**

- making a photo inspired by the work of a Master recognized as an outstanding representative of his age in the field of visual arts (painting, graphics, sculpture, photography, film) using contemporary models and objects;

or

- making a photo of the selected Master’s work and its computer processing.

**The terms of the competition:**

- each participant may submit any number of previously unpublished works to the competition and not reported to other competitions;
- the work must be done by one author;
- collective works will not be qualified for the competition;
- size of the work not smaller than A5;
- Photographs should be sent in two forms:
  - **printed**, sent by post to the correspondence address of the organizer,
  - **electronic**, sent to the e-mail address: [sekretariat@ddkbronowice.pl](mailto:sekretariat@ddkbronowice.pl) (the maximum of email attachment size is 25MB) or a CD or DVD attached to a traditional parcel;
- please attach a photo of the Master’s work that was an inspiration to the competition entry;
- the work should be legibly described in a printed letter according to the application form;
- the submitted works become property of the Organizer;

## Information clause of Dzielnicowy Dom Kultury „Bronowice” in Lublin

1. Personal data of competition participants are used on the basis of personal data protection regulations, including the Act of 10 May 2018 on the protection of personal data (Journal of Laws 2018 Pos. 1000), Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and the repeal of Directive 95/46 / EC (General Data Protection Regulation/ GDPR).

In addition, you have the right to withdraw your consent to the processing of your personal data and remove them from our database. You also have the right to request a processing restriction and to object to the processing and transfer of data. If you violate any provisions of the Personal Data Protection Act, you may also file a complaint to the supervisory body, i.e the Office for the Protection of Personal Data.
